

**ORDINANCE BY THE CITY COUNCIL OF THE CITY OF BEDIAS,  
TEXAS CHANGING THE CITY OF BEDIAS, TEXAS TO A TYPE A  
GENERAL LAW MUNICIPALITY**

WHEREAS, the City of Bedias, Texas (the "City") has been incorporated as a Type B general law municipality; and

WHEREAS, the City of Bedias contains one or more manufacturing establishments within its corporate limits; and

WHEREAS, it is the desire of this City Council that the City of Bedias change to a Type A general law municipality in the manner permitted by Sections 6.011 through 6.014 of the *Texas Local Government Code*;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEDIAS, TEXAS:

1. That it is officially found that the above recitals (including but not limited to the recital regarding the presence of one or more manufacturing establishments within the corporate limits of the City) are true and correct.
2. That the City of Bedias hereby changes to a Type A general law municipality having the powers of a Type A general law municipality.
3. That it is officially found and determined that this Ordinance was adopted at a meeting at which at least two-thirds of the governing body of the municipality were present at a regular meeting with the vote to be recorded in the official minutes of this City Council's proceedings.
4. That it is further found and determined that this Ordinance has been signed by the Mayor, that a copy of this Ordinance has been attested by the City Clerk or City Secretary under the corporate seal of the City, and that a copy of this Ordinance shall be filed and recorded in the office of the County Clerk in the county in which the City is located.
