

AN ORDINANCE RELATING TO SPEED
ZONES WHICH SPECIFICALLY DESIGNATES
ADDITIONAL AREAS IN THE CITY OF
BEDIAS IN WHICH RATES OF SPEED OF
THIRTY (30) MILES PER HOUR OR MORE
ARE AUTHORIZED; RESCINDING ALL
PARTS OF ORDINANCES IN CONFLICT
HEREWITH; AND DECLARING THAT
ATTENDANT FACTS NECESSITATE
IMMEDIATE ACTION.

BE IT ORDAINED BY THE CITY OF BEDIAS:

SECTION I. That any and all ordinances or parts of ordinances relating to speed zones on FM 1696 and SH 90 in the City of BEDIAS are hereby rescinded, and the following are additional specifically designated areas in which a rate of speed of thirty (30) miles per hour or more is authorized.


- A.) FM 1696, for traffic moving in an easterly direction for 0.211 miles from the Bedias western city limit, the speed limit shall be fifty (50) miles per hour. For the next 0.200 miles to the intersection with SH 90, the speed limit shall be forty (40) miles per hour. For the next 0.307 miles, the speed limit shall be thirty-five (35) miles per hour. For the next 0.364 miles, the speed limit shall be forty-five (45) miles per hour. For the next 0.395 miles to the Bedias eastern city limit, the speed limit shall be fifty-five (55) miles per hour.
- B.) FM 1696, for traffic moving in a westerly direction for 0.395 miles from the Bedias eastern city limit, the speed limit shall be fifty-five (55) miles per hour. For the next 0.364 miles, the speed limit shall be forty-five (45) miles per hour. For the next 0.307 miles to the intersection with SH 90, the speed limit shall be thirty-five (35) miles per hour. For the next 0.200 miles, the speed limit shall be forty (40) miles per hour. For the next 0.211 miles to the Bedias western city limit, the speed limit shall be fifty (50) miles per hour.

C.) SH 90, for traffic moving in a northerly direction for 0.252 miles from the Bédias southern city limit, the speed limit shall be sixty (60) miles per hour. For the next 0.202 miles, the speed limit shall be forty-five (45) miles per hour. For the next 0.327 miles, the speed limit shall be thirty-five (35) miles per hour. For the next 0.233 miles, the speed limit shall be forty-five (45) miles per hour. For the next 0.244 miles to the Bédias northern city limit, the speed limit shall be fifty-five (55) miles per hour.

D.) SH 90, for traffic moving in a southerly direction for 0.244 miles from the Bédias northern city limit, the speed limit shall be fifty-five (55) miles per hour. For the next 0.233 miles, the speed limit shall be forty-five (45) miles per hour. For the next 0.327 miles, the speed limit shall be thirty-five (35) miles per hour. For the next 0.202 miles, the speed limit shall be forty-five (45) miles per hour. For the next 0.252 miles to the Bédias southern city limit, the speed limit shall be sixty (60) miles per hour.

SECTION II: WHEREAS, the preservation of the general welfare of the public necessitates immediate action, this Ordinance shall be effective from and after the date of its passage as provided by the Charter of the City of Bedias.


